DECLARED CANDIDATES FOR NATIONAL OFFICE

The delegates of the National Assembly at the 57th National Convention will elect a new National President (3-Year Term), National Vice President (3-Year Term), Committeeman-at-Large (3-Year Term), Committeeman-at-Large (6-Year Term) and National Collegiate Representative (3-Year Term).

Due to the unusual circumstances that prevent us from having an Official Nominating Committee, we asked that all Brothers who intend to run for office file a Candidacy Declaration Form by June 30, 2022.

The declaration only provides notice of *intent to run for election to a declared office*. Each declared candidate must first be formally nominated by a delegate to the National Assembly, with the nomination being seconded by a different delegate, in order to stand for election. All candidates must be members in good standing who have registered for the National Convention.

CANDIDATES FORUM

ELIGIBILITY

To participate in the Candidates Forum during the 57th National Convention, a candidate must meet the following criteria:

- 1. He is formally nominated by a credentialed delegate of the National Assembly.
- 2. His nomination is seconded by a different delegate of the National Assembly.
- 3. He meets qualifications of the office for which he is being nominated.
- 4. He filed a Candidacy Declaration Form by June 30, 2022.
- 5. He is registered to attend the 57th National Convention.

ABOUT

The Candidates Forum is a formal setting in which candidates will be asked a series of questions to help the voting body determine the best candidate for each position. The Forum will be facilitated by a moderator who will ask the questions of the candidates.

SUBMIT CANDIDATE QUESTIONS

We are accepting questions from the Brotherhood-at-large to be considered for use during the Candidates Forum. All questions posed to the candidates will be asked by the moderator of the Forum.

CANDIDATES FOR PHI MU ALPHA SINFONIA'S

NATIONAL PRESIDENT

QUALIFICATIONS FOR OFFICE

Bylaws, Title I, Article III, Section 1.

The National President is a member in good standing, who:

A. has served at least three (3) years as a member of the NEC; or

B. has served at least seven (7) years as a PG; or

C. has been a member in good standing for at least fifteen (15) years.

The National President may succeed himself, but may not serve more than two consecutive terms.

TERM OF OFFICE

Bylaws, Title I, Article III, Section 2.

The National President serves a term of three (3) years, beginning at his installation during the National Convention at which he is elected and concluding when his successor has been elected and installed.

POWERS AND DUTIES

Bylaws, Title I, Article III, Section 3.

The National President is the chief executive of the Fraternity. He presides at National Conventions and at meetings of the NEC. He announces no later than March 1 prior to a National Convention to members of the National Assembly the place, date, and time of the first meeting of the National Convention, and publishes the official docket. He approves proceedings of the National Convention. He or a staff member appointed by the NEC supervises the National Staff. He installs chapters or may appoint another member for that purpose. Subject to the approval of the NEC, he:

A. appoints a PG for each province by September 1 following the National Convention;

B. appoints a National Historian and members of national committees and commissions;

C. appoints a member to fill a PG or standing committee vacancy;

D. divides the United States into provinces.

He may:

A. approve PG removal of province, chapter, or alumni association officers;

B. grant special dispensations to enable a chapter to deal with an unusual situation;

C. grant permission for a chapter to initiate more than two honorary members per academic year;

D. grant permission for a member to be an honorary member of more than one chapter;

E. request or authorize duties of the National Vice President; and

F. remove his appointees from their positions at any time.

Subject to the approval of the NEC, he may:

A. appoint a DPG for any province; and

B. excuse a chapter from meeting financial obligations.

MY VISION FOR PHI MU ALPHA

"It is clear to me that as an organization we have lost our way. If you were to ask 100 Brothers to define our purpose for being, you would receive 100 separate responses. Phi Mu Alpha must embrace and embody sincerity in all of our philosophies, goals, and structures. If the Fraternity relied upon its leadership and membership to move with true sincerity of purpose, we would find that all other obstacles are not insurmountable. That sincerity will manifest in the focus on the well-being of ALL of our Brothers and the facilitation of exalted experiences. My favorite fraternal quote incorporates the concept of "be and not seem". Sinfonia must return to the embodiment of our ideals, rather than paying superficial lip service to the same. "

MY QUALIFICATIONS

"I am uniquely qualified and positioned to assume the duties of National President. I served my undergraduate chapter as secretary and fraternity education officer. I was a multiple-term Collegiate Province Representative and delegate for Province 27 at the 2000 National Assembly. Since 2011, I have served as Governor in Province 30 and as a delegate to every National Assembly since. Professionally, I am an Arts Administrator with over a decade and a half of experience. My Master's degree in Arts Administration is geared explicitly toward not-for-profit management. My forthcoming Doctorate is in Education and Organizational Change. My intent in embarking upon my professional and educational pathways was not necessarily to apply them to Sinfonia. However, I am fully prepared to serve the Fraternity by utilizing my accumulated experience and skills. Sinfonia requires leadership that is well-versed in not-for-profit organizational structure as well as in fraternal philosophies."

MY REASON FOR CANDIDACY

"Candidly, Brothers, this is no longer a matter of personal wishes. The Fraternity is in the midst of an existential crisis and needs leadership to address the multiple concerns that threaten our organization. These concerns exist on nearly every level of the Fraternity and will require measured and experienced attention to ensure their resolution. For years, I had no driving interest in seeking a position on the National Executive Committee. I was content to be a helpful, guiding presence for the Brothers within my home state. Over the last several years, it's become increasingly clear that I have the personal and professional tools to assist this Fraternity that I care for so deeply, on a National level. "Since my undergraduate days, I have participated in or facilitated both strategic planning and financial budgeting and oversight in each organization that I have been associated with, professionally. This includes the UNC Pembroke Digital Academy, the Education Department of the Columbia Museum of Art, the Boys and Girls Clubs of the Midlands, the Sumter County Gallery of Art, and the Lake City ArtFields Collective. In addition, I have served as Province Governor and Treasurer for Province 30 since 2011. In those positions, I have facilitated annual strategic planning sessions with Province Leadership and Province Council, as well as preparing and managing a Province Budget for our six active chapters, alumni association, and Brothers.

MY REASON FOR CANDIDACY

The Indianapolis Legal Aid Society and Foundation raises one million each year and has a significant endowment. While Chairman of the Indianapolis Valley of the Scottish Rite, our Cathedral is worth several hundred million dollars and costs \$3,500 per day to operate. The Indianapolis Childrens Dyslexia Center raises \$100,000 each year and has an endowment of two million. At Extended Hand Prison Ministries we employ a full time minister and raise over \$100,000 each year. I also supervise my law firm, including staff and payroll, advertising, computer programs and technology, insurance, and billing"

National Vice President serves a term of three (3) years, beginning at his installation during the National Convention at which he is elected and concluding when his successor has been elected and installed.

POWERS AND DUTIES

Bylaws, Title I, Article III, Section 6.

The National Vice President assumes the duties of the National President in the absence or incapacity of the National President. He performs duties as may be requested and authorized by the National President or the NEC.

Bylaws, Title I, Article III, Section 8.

A Committeeman-at-Large serves a term of six (6) years, beginning at his installation during the National Convention at which he is elected and concluding when his successor has been elected and installed. The National Assembly elects one Committeeman-at-Large at each National Convention, so that the terms of the Committeemen-at-Large are staggered by three years.

POWERS AND DUTIES

The Committeemen-at-Large serves as a member of the NEC.
